

New Life's mission has never been about politics, but we understand that the legal issues surrounding abortion have an incredible impact on our centers and even more, on our clients. Although it may be easy to become disheartened by the deception we have witnessed this summer, Paul exhorts us in Galatians 6:9, "Let us not grow weary in doing good." As the political divide continues, New Life has never been more committed to our mission. We will continue to work to meet the needs of our clients with such faithfulness and fervor that abortion becomes *unthinkable*.



On June 24th, the Supreme Court ruled to overturn Roe v. Wade. This ruling did not outlaw abortion, but it returned the decision to the state level. While we were thankful for this historic decision, our celebration felt short-lived. You may have heard rumors about a group called #JanesRevenge - a pro-abortion group acting with threats and violence against pregnancy centers like ours across the country. While we have not been the target of their most extreme attacks so far, we have seen threatening posters put in the Phillips community, sidewalk chalk outside our University office containing similar messages, and multiple inflammatory and misleading articles written about our services.

Abortion access is protected by the Minnesota constitution.

July 11, 2022, a Ramsey county judge declared most of the MN abortion restrictions unconstitutional. The following restrictions were immediately removed: 24 hour waiting period; parental notification requirement for minors seeking abortion; and requirement that only physicians perform abortions and that abortions after the first trimester to be performed in a hospital.

The MN Attorney General recently put out a consumer warning against pregnancy centers like ours.


First Care offers free lab quality urine-based pregnancy testing, options counseling, STI testing and treatment, ultrasounds, and prenatal classes. Services are conducted by licensed professionals – we have four RNs on staff, as well as a Nurse Practitioner and OBGYN who provide direct services, when needed.

The Abortion-Pill Reversal is "unethical" and "not based on science"

Abortion pill reversal is safe and completely based on scientific research and testing. According to initial studies, APR has a 64-68% success rate. Progesterone, the medication used to outcompete the first abortion pill, is approved by the FDA and is routinely used with women at high risk for miscarriage.

Pregnancy centers' primary goal is to "prevent people from accessing abortion care as well as contraception" Our goal is to ensure that women are empowered to make fully informed decisions about their pregnancy, to help eliminate barriers, and provide practical, tangible support.

Pregnancy centers are only "probirth" and don't care about the baby after it's born New Life is not and never has been only "pro-birth". We provide the most comprehensive care possible for the mother, her baby, partner, and anyone else involved – no matter what her decision is. Our parenting program goes through age 5.

## **ACOMMUNITY AT WORK**



### **ODAM COMMUNITY CARE CLINIC**

Odam Community Care Clinic is the non-profit arm of Odam Medical group that is a welcoming family practice serving patients in Minneapolis. Robert Larbi-Odam, MD, MPH, and the team are multilingual and communicate to patients about their conditions and treatments in easy-to-understand terms. They frequently perform

physical exams and well-child exams to track children's development as they age. They also offer prenatal and post-natal care, Doula services, treatment for acute and chronic illnesses, and men's health and women's health care visits.

Our new building is also a new service site for Odam Community Care Clinic, where their medical team can serve new and existing clients with compassion, listening to patient concerns and allowing them to take active roles in their own care.



### MAD DADS

Since 1998, the Minneapolis Chapter of MAD DADS (Men Against Destruction and Defending Against Drugs and Social Disorder) has been dedicated to addressing the issues of drugs, gangs, and violence in the Twin Cities. MAD

DADS' mission is to encourage, motivate, and guide committed men and women in the struggle to save themselves and their communities and children from the socials ills that plague neighborhoods. Our vision is to recruit and engage parents to become vocal, visible, and vigilant in restoring safe communities and healthy families. The Minneapolis Chapter of MAD DADS has served more than 80,000 families since our beginning, and we will continue to work to keep our communities safe.

We have hired MAD DADS to provide security for our building. Our security officer, Wallace, is pictured above.



### EMERGE MOTHERS

Emerge Mothers Academy (EMA) equips single moms

with skills, resources, confidence, and the supportive community they need to increase or maintain stability and build a better life for themselves and their children. Our services are designed to help single moms advance their education, employment status, financial health, parenting skills, mental health, and/or support network.

Our new building will be another service site for them as they provide work preparation and financial literacy classes, entrepreneurship microloan grants for single mothers, and parent mentoring.





# IN OUR CENTERS...

Overall, our centers' daily operations have remained the same. We continue to assist clients in life-affirming decisions with the love and compassion of Christ as we have for almost 50 years. However, we have seen a few exciting changes in the months following the Supreme Court's decision to overturn Roe v. Wade.

Right away, we received an overwhelming amount of encouraging calls from supporters, community members, and even clients. One neighboring restaurant gave gift cards to our staff for a free lunch. A client sent a thank you note saying how appreciative she was for the material items and support she's received from our center. And it is such a blessing to see our clients continue to refer their friends and family members to us.

Additionally, we've had a wave of people seeking to get involved! We have received generous donations of diapers, equipment, clothing and formula. We have also had more volunteer applications than we can process. Many volunteers have asked how they can support us through prayer as well. As a result,

we are opening each office for a designated time each week to allow prayer supporters to come in and pray protection over our staff, clients, and facilities. We see the fruit of our prayer supporters each day and are so thankful for them!

Lastly, we have been very busy with ultrasounds. Ultrasounds for women who are considering abortion are **up 140%** from this time last year.

The Lord is faithful, and He continues to sustain us with reminders of His goodness to us in our daily interactions with the clients He brings to us. In one of our offices, a client recently came in to use her points in the clothing closet. Her young son was very interactive and charming with our staff. It was clear that he is so precious to his mom, who was struggling with her decision to parent when she first came to us a few years ago. It was a special reminder to us of the value of each life and our role to faithfully serve Him each day, regardless of the political climate.

When the SCOTUS ruling was released, several clients expressed feeling pressure to make a decision about their pregnancy right away. Even though Minnesota will not be restricting abortion access, some clients have been experiencing more uncertainty and desperation in their situations. It's heartbreaking to witness their anxiety about the situation, but I'm so glad we can be here to support them.

### WHY DO YOU LIKE WORKING AT FIRST CARE?

I like working at First Care because I can be there for men and women in some of their hardest and happiest moments. Whether it's an STI appointment, pregnancy test, or ultrasound, our clients are often coming to us in times of uncertainty. Being

able to provide tangible help to these clients in the form of free medical services, education on medical concerns, or being available to talk through any of their concerns is what makes me love my job.

### WHAT HAVE YOU BEEN SURPRISED BY WHILE WORKING AT FIRST CARE?

I have been surprised to see how great the need is for safe, free, and confidential places like First Care. It seems like no matter how many appointments we have available, there is always a need for more. I have also been surprised to see who our clients really are. Stepping into my current role at First Care, I made assumptions as to who would need STI testing or who is facing an unexpected pregnancy. However, I have seen clients from all stages of life come to First Care. I have served clients from teenage years to 70s. I have served clients with low and high incomes, still in school, graduated with a PHD, married and unmarried. Seeing the wide range of clients that have come to First Care has helped me understand that anyone can end up in a tough situation, and it is never our place to judge their circumstances. I have loved getting to know each of our clients and help them navigate whatever situation they find themselves in.

### A STORY OF HOPE

A very young client and her mom walked into First Care for what they thought was the daughter's abortion appointment. As we met with them, we quickly realized the misunderstanding and clarified that we do not provide or refer for abortions. We offered her an ultrasound and surprisingly, the daughter accepted. However, she was looking at her phone during the entire scan and did not want to talk about the ultrasound or anything about her pregnancy. As we were finishing the scan, her mom exclaimed, "That's a baby in there! Don't you see, that's life!"

After the appointment, we offered to schedule another ultrasound appointment if it would be helpful for her. She decided she wanted another ultrasound and came back later by herself.

This time, she was attentive and was able to see her baby squirming all around. At one point, it looked like the baby was waving at the screen. The client smiled and started asking every question she could about pregnancy, delivery, and childbirth. This time, she didn't even touch her phone. She left the appointment with a handful of ultrasound pictures, excited to parent her squirming little baby.

### **HOSPITAL CALLS**

Placing for adoption is a difficult and


loving decision. We often hear birth moms share their stories of how they came to the decision of adoption, discussing openness with their social worker, meeting and choosing and adoptive family, and preparing for the birth and hospital time.

However, that is not every birth mom's story. Some birth moms make an adoption decision in the hospital after giving birth. Sometimes she is unsure about her parenting decision and wants to know more about adoption, or sometimes her circumstances have changed making adoption more of an option. And, in some situations, the county is involved and will allow the birth mom to make a private adoption plan instead of child protection stepping in. In these situations, the hospital social worker or the birth mom will reach out to talk through the option of adoption

while the mom is still in the hospital. This is not every birth mom's story, but the emotions and process of making an adoption plan, meeting with her social worker to discuss openness, choosing an adoptive family are all the same – they're just compacted into a few days rather than the months before birth.

I've had the privilege of meeting with several birth moms this way. Yes, it is indeed a privilege to be called upon in the moment of crisis and be entrusted by the hospital staff and birth mom to navigate this important time in mom and baby's lives. At New Life Adoptions, we also provide interim care to give the mom more time to make this very important decision. Because we are both a pregnancy center and an adoption agency, we are able to offer services for either a parenting or adoption plan and truly support the mom no matter what she decides.
